

Outdoor Emergency Notification System Test Wednesday, June 7

Public Safety: Tuesday June 6, 2023

Georgia College & State University will test the Outdoor Emergency Notification System (siren system) Wednesday, June 7, 2023. This test is scheduled to occur the first Wednesday of every month between 10 a.m. and noon and last approximately one minute. No action is required during the testing, and all campus operations should continue as normal. A message stating that this is a test will precede and follow the "alert" tone. In the case of an actual tornado warning, the message would advise of a tornado warning, and the tone would cycle through. This would be repeated every five minutes until the warning expires or is canceled, at which time an all-clear message would sound. The audible system test will only be tested when clear sky conditions are present. Tests will not occur when skies are dark or severe weather is predicted for the area on the day the test is scheduled to occur. In this case, the test will be rescheduled for later in the month.

There are three sirens operated by GCSU in Baldwin County: one on West Campus and two on Main Campus.

This testing program is designed to maintain a reliable warning system and to meet recommended testing guidelines. Additionally, we want to maximize the effectiveness of the Outdoor Emergency Notification System. By performing these tests, we hope to enhance awareness and education regarding emergency preparedness at Georgia College and within the local community.

UPCOMING CRITICAL DEADLINES

The fiscal year-end is approaching, which means we must accurately account for the institution's financials before closing out the fiscal year June 30, 2023. This includes ensuring that any funding that can possibly lapse (go back to the state) is accounted for properly. As a state entity, we are governed by certain purchasing policies and procedures, which include deadlines for purchases of varying dollar amounts. To ensure that expenditures are properly reported during the transition of fiscal years, we have deadlines for receiving transactional items. These deadlines, as listed below, are necessary to guarantee that transactions are properly executed and that our financials are appropriately reported.

CRITICAL DEADLINES

Travel cutoff dates:

- June 16, 2023 Approved paper travel expense statements (for non-employee, encumbered or international travel) are due by 5 p.m.

Cost-of-Living Adjustment (COLA) for Fiscal Year 2024

Human Resources, Office of : Thursday June 8, 2023

Faculty and Staff Members,

We are pleased to announce the Governor and state legislators have approved a Cost-of-Living Adjustment (COLA) for full-time, benefit-eligible state employees to be effective July 1, 2023. Our goal is to share important information about eligibility and how the COLA increases will be implemented.

The COLA will be administered in compliance with guidance from the Governor's Office of Planning and Budget (OPB) and the University System of Georgia Board of Regents (USG) as follows:

- COLA Amount: A \$2,000 COLA will be awarded to all eligible employees of the USG/Georgia College & State University.
- Employee Eligibility: All regular, fully benefited (30+ standard hours) faculty and staff of the USG/Georgia College & State University who are actively employed on July 1, 2023, are eligible to receive the COLA.
- Ineligible Employees: Non-benefited employees, including temporary and those working less than 30 hours are not eligible for COLA.
- Details Regarding the Salary Adjustment:
 - The COLA is an adjustment to base salary.
 - The COLA will be prorated based on full-time equivalency (FTE).
 - The COLA is subject to all applicable FICA taxes, federal income tax, and state income tax. Federal and state income tax will be withheld at the employee's normal tax rate.
 - The COLA is eligible for retirement benefits.
- All amendments to employee pay will be reflected in OneUSG's Employee Self-Service Payroll tile by their respective pay dates listed below:
 - Biweekly Paid: Eligible non-exempt employees will begin receiving the increase on their July 14th paychecks.
 - Monthly Paid: Eligible exempt employees will begin receiving the increase on their July 31st paychecks.




Dr. Scott Buchanan Invited to Finnish Embassy

Phish Alert - Be aware of phishing and fraud scams

Information Technology: Tuesday June 13, 2023

GCSU Information Security wants you to know that we are under a constant state of attack from hackers. We have seen a high number of phishing emails come in recently and we wanted to make you aware of a scheme that seems to catch people by surprise.

The latest trend is to create a form in Google Docs that asks you to provide your username and password. Often the sender purports to be either someone in IT or is pretending to be Cathy Cox. The subject line will be something similar to "[Ext GC] Cathy Cox has shared a document with you."

In every case where you receive an email that you aren't expecting, please use the tool that the university has purchased to help you determine whether it's legitimate; Phish Alert. It's found in every version of Outlook; it's the white envelope with the orange fish hook through it. Routing emails through Phish Alert helps you identify illegitimate emails and it informs us in Information Security that we have an issue so that we can address the issue promptly.

Please be very wary of clicking URLs or opening attachments when the email is branded as external with a warning. Unless you were expecting something specific from a vendor, don't open those. Hackers use real-world scenarios to trick you into providing your information. We receive these scams on campus every day.

GCSU education dean completes study on teacher pipeline, meets with legislators at Capitol

College of Education: Thursday June 22, 2023

The dean of Georgia College & State University's John H. Lounsbury College of Education recently visited legislators at the Capitol in Washington D.C. to advocate for federal funding in support of teacher preparation. Dr. Joseph Peters was there as part of the American Association of Colleges for Teacher Education Washington Week



Peters is the immediate past president of the Georgia Association of Colleges for Teacher Education. In that role, he recently completed a study on issues related to the teacher pipeline in Georgia.

The study proved Georgia has an immediate and future need for teachers. Georgia Chamber of Commerce President Chris Clark—a Georgia College graduate with a master's in public administration—predicts that the education sector's need will increase from the current 7,000 vacancies to 40,000 by the year 2025.

"We are at a critical juncture in the need for teachers in the state of Georgia," Peters said. "Conversations like the one we had in Washington are a crucial step in the right direction. We're hoping these efforts shine a light on the issue and can support federal funding for future grants."

Peters met with Senator Jon Ossoff, members of Senator Raphael Warnock's team and members of Representative Austin Scott's team, among others.

Morris earned a Fulbright to North Macedonia and a Marshall Scholarship to the UK, where he completed M.S. degrees in International Relations and Conflict Resolution at the London School of Economics & Political Science and King's College London, respectively. He now works as a Young Global Professional at the Atlantic Council's Europe Center and this summer is pursuing advanced study in South Slavic Languages at the Melikian Centre through a U.S. State Department Title VIII Critical Language Fellowship.

Impact Your Teacher Effectiveness Ratings through the Objective Selection Form (OSF)

Center for Teaching & Learning: Tuesday June 27, 2023

The Objective Selection Form (OSF) is open for the summer 2023 semester and ends by the closing date of student surveys. The OSF allows faculty to identify targeted learning objectives to measure teaching effectiveness, and faculty response to the OSF drives summative results on the Student Rating of Instruction Survey (SRIS). The primary indicator of teaching effectiveness is how well students rate their progress on learning objectives that faculty mark as important or essential on the OSF. Since every course is different, this research-based instructor-driven model interpreters teaching effectiveness based on indicators identified by the instructor. Most instructors, familiar with their course learning objectives, decide and mark the OSF in ten (10) minutes or less per course.

GCSU's Center for Early Language and Literacy holds annual summit on childhood literacy

Center for Early Language & Literacy: Wednesday June 28, 2023

Georgia College & State University's <u>Sandra Dunagan Deal Center for Early Language and Literacy</u> holds its 2023 <u>Governor's Summit on Early Language and Literacy</u> July 12-13 in an ongoing effort to boost early language and reading skills in children throughout Georgia.



The summit brings together state legislators, literacy experts, superintendents, professors and teachers to share evidence-based research and best practices for reading. Participants will attend sessions to collaborate on ideas, exchange stories and learn more from experts across Georgia.

This year's theme, "Supporting Emergent Literacy Development with Evidence-based Practices for Young Children," especially honors the life of former Georgia First Lady Sandra Deal, who passed away in August 2022 after a courageous battle with cancer.

Mrs. Deal earned her bachelor's and master's in education at Georgia College & State University when it was known as The Woman's College of Georgia. In 2017, the Deal Center opened and was named in her honor as the state's designated research and training facility for advancing early language and literacy skills in children from birth through third grade.

"We are pleased that the Georgia General Assembly chose her alma mater to open the Sandra Dunagan Deal Center for Early Language and Literacy here," said Georgia College President Cathy Cox. "Mrs. Deal was passionate about literacy and worked tirelessly to make sure every child got the best early start in life with strong reading skills."

"She was a model for volunteerism and community service—a living example of what it means to care for others and especially for children," Cox said. "We are honored to help carry on her legacy."

A portrait of Mrs. Deal holding one of her favorite children's books will be unveiled at a dinner event Wednesday, July 12. The 36 x 48 acrylic painting was created by Damara Sochacki, who graduated from Georgia College in May with a degree in art.

There will be a "Read Aloud" station throughout the two-day event—to honor Mrs. Deal's goal as first lady of Georgia to read to school children in all 159 counties of the state. All

participants can be recorded reading a children's book at the Read Aloud station. The recordings will be available for children to listen to on the Deal Center website.

Other highlights include keynote speaker, former Patriots wide receiver and UGA Bulldog star Malcolm Mitchell, who'll talk about the state of literacy in America. At dinner, autographed copies of Mitchell's new children's book, "Hey Georgia," will be handed out.

Georgia College's bobcat mascot, Thunder, will also be on hand throughout the summit to stamp his pawprint on copies of the book, "Thunder Learns to Read," by Dr. Linda Bradley, Georgia College's program coordinator for Reading, Literacy and Language.

Special guests at the summit are expected to include: former Georgia Gov. Nathan Deal and family members; Gov. Brian Kemp and First Lady Marty Kemp; state Senators Billy Hickman and Chuck Payne; Amy M. Jacobs, commissioner of the Georgia Department of Early Care and Learning; Dr. Ryan Lee-James, director of the Rollins Center at the Atlanta Speech School; Dr. Caitlin Dooley, executive director of Voices for Georgia's Children; Dr. April Aldridge, deputy superintendent of the Georgia Department of Education; Joy Hawkins, executive director of the Governor's Office of Student Achievement; and Georgia College's new executive director of the Sandra Dunagan Deal Center for Early Language and Literacy, Dr. Lindee Morgan.

This spring, Gov. Kemp signed two bills to improve literacy rates among students in Georgia. Senate Bill 211, championed by Sen. Billy Hickman, creates the Georgia Council on Literacy, a panel tasked with reviewing the state's literacy programs and outcomes and making recommendations for improvements. House Bill 538, known as the Georgia Early Literacy Act, requires teachers to be trained on evidence-based literacy instruction.

"This summit's a little bigger, and it's the first since Mrs. Deal's passing with a larger lineup of presenters from across the state of Georgia compared to previous years," said Kimberly Scott, administrative office manager at the Deal Center. "With the new House and Senate bills, there's a higher focus on literacy. We want people to come and see the changes and learn how they can make an impact in their communities."

"We hope everyone takes something back with them to implement and re-energize them," Scott said, "so we're ready for the next school year."

About 200 participants are expected. Opening remarks and general sessions are 1 to 4 p.m. July 12 followed by a fundraising dinner honoring Mrs. Deal in Magnolia Ballroom on the Georgia College campus in Milledgeville. July 13 continues with breakout sessions 8 a.m. to 4 p.m. in Atkinson Hall and Magnolia Ballroom. Topics include the future of literacy in Georgia; instructional coaching; transformational approaches in teaching; using science to implement structured literacy; building connected communities; mentoring programs; and how font affects reading comprehension.

dinner will be 6:30 to 8:30 p.m. in Magnolia Ballroom. This semi-formal event costs \$125 per person and includes dinner, live music, presentations, the unveiling of Mrs. Deal's portrait and an autographed copy of Mitchell's book. High Demand Alert - Electricity Reduction for 6/28

Facilities Management: Wednesday June 28, 2023

Georgia Power has issued a "day-ahead" Alert for Wednesday, 6/28 as higher temperatures result in peak electricity demand that significantly impacts pricing (pricing will quadruple to \$0.30 per Kilowatt Hour during the peak demand period). Judging from forecasted temperatures, we expect this status will persist throughout the week. The campus community is urged shut down all non-essential lighting during the peak hours of 1 p.m. to 8 p.m. At your discretion, consider unplugging any equipment you deem non-essential. If you have access to windows, use the natural light. When not using natural light, close window blinds. Turn lights off when you leave your office. Keep temperature setpoints at 75 F or higher. All of these measures will help tremendously.

Peak Power - Work Schedule Adjustments for June 29 & 30

Dear Campus Community:

Due to elevated electricity demand across the grid, GCSU is subject to a significant cost premium on electricity consumption today with this cost premium forecasted to persist through Friday. This elevated demand is particularly acute during peak hours of 1 p.m. and 8 p.m. with a programmed quadrupling of rates today and considerably higher rates (by a factor of 10) tomorrow.

In light of this high demand period and comparatively low operations tempo, our institution has made some adjustments to the work schedule for Thursday, June 29 and Friday, June 30.

In order to be good stewards of our resources and to limit our environmental impact, we ask that all personnel who can complete their university duties by working remotely from home to please do so for the remainder of this week.

We hope this initiative, leading into the extended holiday weekend will help us mitigate these increased costs during the peak periods laid out in yesterday's email from Frank Baugh, AVP for Facilities Management.

Making adjustments like this now will help give the university the opportunity to offset higher electricity costs later in the summer when the higher temperatures will remain, but our employees' time on campus can be more crucial. Last year, rising electricity costs made as much as a \$13,000 impact on our power bill in a single day.

We fully understand that faculty and staff involved in face-to-face classes, the Bridge Scholars program, student support services and summer camps, public museums, and ongoing end of fiscal year activities, some personnel may be required to remain in the office. It will be up to the discretion of department supervisors and leadership teams to make the decisions of who will be eligible to work from home.

To reiterate – Thursday and Friday are not holidays. All employees working from home are required to be available for our standard summer hours: 8 a.m. to 5:30 p.m. on Thursday with a 30-minute lunch break, and again from 8 a.m. to noon on Friday. If you are already scheduled to be on annual or sick leave, this opportunity does not change that request.

We request that when you leave work, that all employees adhere to the suggestions provided in Mr. Baugh's message: closing window blinds, turning all office and common area lights off, setting your thermostat to 75 degrees, turning off all computers, and unplugging appliances where available.

Actions like this will help our university as we continue to support world-wide conservation efforts, and address the tight budgets we face and will face in the coming year.

Evans said he plans to get settled and review current practices. He is already excited to explore potential applications of technology to lead the College of Health Sciences into the future of healthcare.

He hopes to see the college work to enhance the Center for Health and Social Issues, investigate applications of Artificial Intelligence (AI) and other technological innovations, and collaborate with other campus colleges to better educate students for tomorrow.

The self-proclaimed outdoorsman enjoys walking his dog, fishing, skateboarding and surfing—as he put it, "anything outdoors."

"The university and the faculty have a great reputation," Evans said. "I'm excited about being here, getting to work with everyone and getting to know them as we start the academic year."

"Other than that," he said, "I'm just happy to be here."
