# **Program Description**

The Montepulciano, Italy, Summer Study Abroad program is a five-week program in Montepulciano, Italy. It is a consortium study abroad program overseen by Kennesaw State University (KSU). The program is built around a general education study abroad model that provides students the opportunity to take core requirements and some upper-division courses in multiple disciplines. # **General Information and Application Process**

Because the Montepulciano, Italy, Summer Study Abroad program is shared among a consortium of USG institutions, faculty members are selected based on a number of criteria including the following:

- Completed GC Faculty application (this form) and two syllabi due to the GC International Education Center by May 10. The KSU online application is due May 20.
- Availability of general education and upper-division courses that students are likely to take and can take without pre-requisites.
- Availability of courses to a majority of students at each of the consortium institutions. (Courses should be able to transfer across the consortium institutions.)
- Attractiveness of courses (including titles and descriptions) to students within and outside the major.
- The balance and variety of course offerings.
- The potential benefits of teaching each course abroad.

Interested Georgia College faculty submit the GC Faculty Application (this three-page form), signed by appropriate department chair and dean, and two syllabi to the GC Montepulciano Campus Rep, Jarris Lanham, at <a href="mailto:jarris.lanham@gcsu.edu">jarris.lanham@gcsu.edu</a> (subject line: Montepulciano summer 2023) by May 10. #### Faculty Commitment to the Summer 2023 Montepulciano Study Abroad Program

If accepted to teach on this program, I understand that KSU will require that I recruit and enroll at least ten (10) students from my campus to participate in the Montepulciano Study Abroad Program. I understand that I may need to enroll more than ten (10) students on this program to receive a full summer salary. I further understand the following:

- Teaching in study abroad is an intensive and comprehensive experience involving faculty members with students in many out-of-class activities. I understand that I will be obligated to not only teach my own formal class sessions, but also to organize and lead students on scheduled course field trips as well as collaborate with other program faculty in scheduling and conducting joint activities.
- I must commit to spending time in the recruitment of students during both fall and spring semesters. Examples of recruitment include speaking in your own classes and those of your colleagues, participating in study abroad fairs, distributing program and course materials, working with academic advisors, and encouraging students outside your discipline to participate in the program. Faculty should also be prepared to attend and take part in representing the program at other institution's study abroad fairs when asked.
- I must attend the Georgia College study abroad faculty trainings. There are usually two per year, the first in early fall semester, the second in early spring semester. KSU will have additional required training sessions and orientations.
- Faculty members who would like to have their spouse or others visit during a portion of the program should submit their plans when completing the KSU application. If their plans are approved by KSU, GC faculty will follow KSU procedures and will arrange and pay for all costs associated with the travel of their guests.
